Thank you for using the discover.swiss service platform. This agreement specifically regulates the operational processing between the service provider, the service user and the discover.swiss cooperative (all referred to as parties) for the provision of information (hereinafter referred to as the offer) on the discover.swiss service platform. On behalf of the Service Provider, discover.swiss makes the Offer available on the Service Platform to interested Service Users. The service user provides the offers to the end customer (hereinafter referred to as customer, guest, buyer) via their own online information system.

By concluding the contract and thus incorporating these GTC-Info into the contract, the platform user also expressly accepts the platform guidelines of discover.swiss (<https://discover.swiss/plattform-guidelines>) and takes note of the privacy policy of discover.swiss (<https://discover.swiss/privacy-policy>).

1 Agency offer discover.swiss

- 1.1 discover.swiss arranges offers in one of the following *service variants*:
 - 1.1.1 *Information Only* - the offer is published in the discover.swiss **info centre**
 - 1.1.2 *Booking link* - a booking link is *explicitly* added to the offer in the **info centre** (variant a) - Information Only) for purchase by the guest in an external booking system
- 1.2 For the publication of offers according to the *service variants a) Information Only* and b) *Booking Link*, the conditions according to the valid platform guidelines of discover.swiss apply to all parties.
- 1.3 Further provisions on the use of the service can be made available by the service provider in the Terms of Service for mediation to service users.

2 Remuneration

- 2.1 discover.swiss may charge the service provider an individually agreed annual fee for the brokerage of offers.
- 2.2 Services provided by discover.swiss in the course of system setup or operation will be charged by discover.swiss at the current rate for digitisation and consulting services or support services (<https://discover.swiss/services>). The fees are subject to statutory value added tax.

3 Inclusion of the general terms and conditions of discover.swiss

- 3.1 This GTC information applies in addition to the GTC of the discover.swiss cooperative.
- 3.2 Insofar as these GTC-Info deviate from the GTC of the discover.swiss cooperative, the provisions of the GTC-Info shall take precedence.
- 3.3 The application of any general terms and conditions of the service user is explicitly excluded.

4 Final provisions

- 4.1 discover.swiss reserves the right to supplement or amend this GTC information at a later date. Changes will only be announced on the URL under which this GTC information is stored at the relevant time. It is the responsibility of the platform user to check this page regularly for changes. The changes will become part of the contract unless the platform user objects within 14 days of notification of the change. Your continued use of the product after expiry of the aforementioned period constitutes your acceptance of the changes to the GTC-M.
- 4.2 The contractual relationship is subject to Swiss law, to the exclusion of the Vienna Sales Convention. The courts of Zurich shall have exclusive jurisdiction for all legal disputes arising from the contract.
- 4.3 Should any provision of these GTC-Info be or become invalid or void, this shall not affect the validity of the remaining provisions. The invalid or unenforceable provision shall be replaced by an appropriate provision that comes closest to what the contracting parties intended or would have intended according to the meaning and purpose of this contract.
- 4.4 In case of discrepancies or interpretation issues between the German and the English version of this GTC, the German version shall prevail.
